Permit Required

Contact the College Fire Marshal at 201-684-6252 or ekutzin@ramapo.edu for assistance with obtaining permits. Permits are issued by the NJ Division of Fire Safety and are required for the following:

Tents: Greater than 30 linear feet or 900 square feet; with or without sides. Note: Use of College owned tents does not require a special permit.

- Overnight Stays: For events held in Assembly Areas (i.e. Friends Hall, Bradley Center, Alumni Lounges, Pavilion etc.) with or without a designated sleeping area.
- □ Mercantile Use: The use of any indoor Assembly Area with occupancy > 100 persons for the sale of merchandise.
- Fireworks: Additional approval from the President's Cabinet is required.
- Cooking/Barbecues: Outside cooking using grease and/or oils including the use of Food Trucks. Use of barbecues other than stationary charcoal barbecues provided on campus or barbecues provided by Dining Services. The use of personal barbecues is PROHIBITED. *Note: Use of College owned grills does not require a special permit.*
- **Open Burning:** Bonfires, campfires, etc. Additional approval from the President's Cabinet is required.
- Carnivals and Circuses: That use mobile structures during the course of the event. Inflatables do not require a fire permit but must have State Inspection Sticker from the NJ Ride Safety Unit. Enclosed structures such as a "Fun House" would require a fire permit.

Note: Applications for permits are processed online via the NJ RIMS system. Credit Cards are the only acceptable means of payment directly to the State. Permits are issued upon satisfactory completion of an on-site inspection by the NJ Division of Fire Safety.

Other/Open Flames – No Permit Required

- **Candles:** The use of candles on campus is strictly limited refer to the RCNJ Candle and Incense Policy.
- Sterno: The use of sterno on campus is limited to certain locations refer to the RCNJ Sterno Use Policy.
- LP Gas/Propane: The use of LP Gas/Propane on campus for other than cooking use, such as generators (must be properly secured and roped off)

Flame Resistant Certifications Required

- Pipe & Drape: Must obtain a Certificate of Flame Resistance from the vendor. Cannot block any fire alarm devices or any EXITs or EXIT signs.
- Skirts for tables, platforms and stages: Must obtain a Certificate of Flame Resistance from the vendor.
- Decorative Materials: Must obtain a Certificate of Flame Resistance from the vendor. Cannot block any fire alarm devices or any EXITs or EXIT signs.
- Floor Plans: A floor plan of reasonable quality and clarity is required for each event. Floor plans must be submitted to the College Fire Marshal. Means of egress cannot be blocked at any time. Exit signs must be clearly visible. Attendance may not exceed the permitted occupancy limits.
- Crowd Manager: A Crowd Manager is required to be on site for all events with attendance or occupancy >1000 people.
- Prohibited Items: Smoke/Fog/Mist Machines, Sparklers/Pyrotechnics, Weapons (real or imitation), Live Vegetation: Holiday Trees, Corn Stalks, Hay Bales & Straw.
