Clarifications

1.) Regarding: issuance of Addendum No. 2

One of the Addendum No. 2 files that had been uploaded to the College's website Thursday morning, January 28, 2016, had been missing the full content and pages within the file identified as Addendum #2 1.28.16 Revised.

That file in its complete form was subsequently emailed to bidders and had been identified as Addendum #2 1.28.16 Revised Complete. On our Construction Projects website the very same Addendum No.2 is identified as Addendum #2 1.28.16-3 revised-2016-01-18.

2.) Q&A No. 10 on page 2 of 3 of Addendum No. 2 makes reference to an allowance for the work described on Drawing A1.0 Note #10. It further references a 'Roof Inspection and Repair Allowance' on page 7 of 7 on the Proposal Form in the amount of \$8,000. Therefore, we do not require unit prices for this work to be entered into the Unit Prices table on page 6 of 7 of the proposal form (that is Unit Prices Item No2 Roof Repairs).
