ADDENDUM NO. 1 Dated May 12, 2017

THE PURPOSE OF THIS ADDENDUM IS TO CHANGE THE FOLLOWING ITEMS:

Make changes to scope of work as identified on the following responses to bidder's questions and/or noted specifications, drawings, and sketches (SK's).

BIDDER QUESTIONS & RESPONSES:

Question 1: Please specify the manufacturer of the Fire Alarm System.

Answer 1: Honeywell.

Question 2: Please specify the ceiling tile model number.

Answer 2: Armstrong / Ultima Tegular #1912 & Superfine XL-2/2/3/4 Spec 2.1 A/1 to match existing.

Question 3: Do the notes regarding spray foam on A9.03G apply to this project or has this work already been completed previously? Please Advise.

Answer 3:	Spray foam insulation has not been completed and is part of the scope of work.
Question 4:	Is the programing of the VAV by Johnson Controls in the contract?
Answer 4:	In Contract – Johnson Controls is the vendor on campus.
Question 5: contract?	For the fire alarm, are shut downs and programming of the fire alarm panel (by United) in the
Answer 5:	In Contract - United Fire is the vendor on campus.

Question 6: The scope of work does not mention architectural millwork, but it is listed as a deduct alternate. Is it included in the base bid?

Answer 6: Yes.

Question 7: Drawing A9.03 shows a table in the center of the space labeled as MT3660, but on A9.01 there is no detail for MT3660. Are we to assume that MT3660 shares the same design as MT3060 except that it is 36" wide instead of 30" wide?

Answer 7: Correct, assume 36" wide.

Question 8: Please confirm (as per the walk through) that in the base bid the exterior door will stay, and spray foam and sheetrock will be installed around it. The drawings call for the door to be concealed with spray foam and sheetrock.

- Answer 8: Doors are to stay, however there is no spray foam over the doors. Typical Batt insulation to be used.
- Question 9: Reference is made to Structural drawings not included in the set. Will these be released?
- Answer 9: No new structural work, see drawings for summary of work. Additional structural drawings will not be provided.
