Meeting Minutes of Wednesday, February 23, 2005 11:00 A.M. to 1:00 P.M. SAB Sanyo Conference Room (A-224)

## **Discussion Items:**

#### **Latin Honors**:

S. Klein distributed the current policy and a proposed policy for Graduation with Distinction (i.e., with Latin Honors) for both first and second baccalaureate degree candidates. The current policy was excerpted from the *Ramapo College of New Jersey The Catalog 2002-2004 Undergraduate* on page 37.

ARC members discussed the suggested changes in GPA ranges proposed by I. Spar, who presented a rationale for raising the minimum levels for graduation with Cum Laude, Magna Cum Laude, and Summa Cum Laude honors. He also reviewed the policy at four New Jersey state institutions of higher education.

S.Klein will request from B.Varano, Institutional Research, a frequency distribution of grade point average (GPAs) by number and percentile rankings of graduates for the past five years. ARC will analyze this data and determine the impact of any proposed change in policy. I. Spar agreed to write a proposal for School Honors.

# Requirements for Second Degree Candidates:

J. Skrzynski explained the differences in credit requirements between second degree candidates who obtained their first undergraduate degree from Ramapo and those who came to Ramapo with a baccalaureate degree from another institution. J. Skrzynski agreed to reword the proposed policy changes for second degree candidates.

## Pass-Fail Grade Option Policy:

F. Shapiro-Skrobe presented her proposed revisions to the current Pass-Fail Grade Option policy. After considerable discussion, she agreed to add an executive summary and to highlight the differences between the current policy and the proposed changes.
