Latin American DNA Donor Project Ramapo College of New Jersey Investigative Genetic Genealogy Center

What is the purpose of this project?

Ramapo College of New Jersey seeks to grow the number of Latin Americans in databases used for Investigative Genetic Genealogy in order to measure the impact to cases of Latin American unidentified decedents.

What is investigative genetic genealogy?

Investigative Genetic Genealogy (IGG) is a process that combines advanced DNA testing with traditional genealogy to identify unidentified remains as well as suspects in violent crimes. IGG has been used to identify more than 150 John and Jane Doe unidentified remains cases since 2018, but its utility is limited in non-European populations.

Who qualifies to participate in this project?

Volunteer participants who are Latin American or Indigenous, or who report they have a first or second degree relative who is Latin American or Indigenous, may participate in this project.

How will voluntary DNA Donors' information be used?

Those who consent to participation in this project will receive a complimentary direct-to-consumer DNA kit from FamilyTreeDNA. Our project leaders at Ramapo College of New Jersey, as well as the DNA Donor, will have access to the DNA test results.

Ramapo College of New Jersey will monitor whether any DNA kits administered are DNA matches to selected John and Jane Doe unidentified remains

Risks of participation in this project:

- By taking a FamilyTreeDNA test, your DNA will become available for "law enforcement matching" in the FamilyTreeDNA database.
 - If you are a genetic relative to an unidentified deceased John or Jane Doe, your DNA may be used to generate investigative leads resulting in identification of the decedent
 - o If you are a genetic relative to a suspect in a violent crime, your DNA may be used to generate investigative leads resulting in identification of the suspect
- By participating in this project, it is possible that your identity may be revealed to the following parties:
 - Other consumer DNA testers in the FamilyTreeDNA database
 - Investigating agencies and Investigative Genetic Genealogy practitioners using the FamilyTreeDNA database
 - Members of the judicial system if your DNA results in identification of a suspect in a violent crime
