For each Federal, State and Institutional Program listed, report the number of undergraduate recipients and the aggregate dollar amounts awarded during academic year 2021-2022

Institutional grants and scholarships (need-based or merit) should be reported on Line 21.

Institutional loans (loans paid from institutional funds) should be reported on Line 22.

When reporting the number of recipients of a particular aid program, **count each student only once per program**, even if two awards were made within the academic year. Of course, a student may be a recipient of several different programs, and thus be reported on several different lines. On the last line (row 36), please supply an unduplicated headcount of all Undergraduates who receive a federal or state need-based aid award.

When reporting dollar amounts, **round the amounts to the nearest thousand**. For example, report the amount of \$2,144,335 as 2144.

Each institution should use its own definition of in-state and out-of-state residency for classification purposes.
