The Honorable Holly T. Schepisi

Senator Holly Schepisi (NJ-39) served as a member of the New Jersey General Assembly from 2012 until March 25, 2021, when she was sworn in as a member of the New Jersey State Senate. She represents the 39th Legislative District, which includes 28 municipalities located in Bergen County. She serves as a member of the Health, Human Services, and Senior Citizens Committee and the Community and Urban Affairs Committee and has been selected as the Republican Conference Leader. While in the Assembly, she sat on the Environment and Solid Waste, Judiciary, Housing, and Appropriations Committees.

In June 2022, Senator Schepisi joined the law firm of O'Toole Scrivo, LLC as a partner. Before joining the firm, she had her own law firm, Schepisi Consulting & Law, LLC, had previously served as vice president of Holy Name Medical Center and president of its Foundation, and was special counsel at Huntington Bailey, LLP.

Experienced in public issues, Senator Schepisi currently serves as counsel to the Park Ridge Board of Public Utilities and previously served as the public defender for the Borough of Oakland and the township attorney for River Vale. She is an executive committee board member of the Bergen Community College Foundation, a board member for the Adler Aphasia Center, the previous President of the Fordham Law Alumni Association, New Jersey Chapter, and serves as an advisory board member of Provident Bank.

Senator Schepisi earned a bachelor's degree in politics and psychology in 1993 from Catholic University of America and a law degree from Fordham University Law School in 1997. She currently resides in River Vale with her husband, Paul, and her two children.
