OPEN ENROLLMENT FOR PLAN YEAR 2021

October 1 - October 31, 2020 is the SHBP and Tax\$ave Open Enrollment period — your annual opportunity to review SHBP and Tax\$ave coverage and make any changes for you and/or your dependents for the 2021 Plan Year. During the Open Enrollment you may:

- Enroll in SHBP plans if you have not previously done so, change to a different SHBP medical plan and/or dental plan, and add eligible dependents – including children up to age 26.*
- Enroll or renew enrollment in Tax\$ave Flexible Spending Account (FSA) plans for the coming plan year.** See the Tax\$ave News and Open Enrollment fliers for information about the FSA plan features offered by Horizon *MyWay*.
