The Roadrunner Financial Group (RFG) is a student club that operates as a Student-Managed Investment Fund, actively managing a \$50,000 stock portfolio on behalf of the Anisfield School of Business. Weekly meetings are held in the ASB Global Financial Markets Trading Lab where we discuss our current stock holdings, the economic factors affecting the current market as well as pitch new investment ideas for inclusion in the RFG Portfolio.

The mission of the Roadrunner Financial Group is to provide a valuable educational experience to its members by allowing them to manage a real dollar investment portfolio. Through rigorous training and hands on experience, members learn about the most important aspects of finance and investing, while developing strong teamwork, public speaking, and analytical skills. 
"Joining RFG was one of the best decisions I made during my time at Ramapo. I learned not only essential tools for investing but how to work as an effective team.
