Whereas: The Student Government Association of Ramapo College of New Jersey is the liaison body to the Faculty, Staff, Administration, the Board of Trustees and the Board of Governors of Ramapo College of New Jersey;

Whereas: Restrooms are a high-traffic area that every person must use on a day-to-day basis, while also providing a space of privacy and safety for many;

Whereas: [The Campus Safety and Security](#), run by the US Department of Education, highlights how sexual assault cases make up a large portion of all criminal offenses at college campuses in 2023;

Whereas: The Office of Title IX serves to create an environment free from discrimination and harassment on the basis of sex, gender, gender expression, sexual orientation, and pregnancy, whilst providing a way for students to report incidents relating to sexual violence and discrimination, as stated on the college's website;

Whereas: The Office of Violence Prevention serves as the center for awareness and education against domestic, dating, and sexual violence, stalking, and other forms of interpersonal violence, as stated on the college's website;

Whereas: The Center for Health and Counseling Services provides preventive and educational services, therapeutic interventions, and supportive communities to all students of Ramapo College, as stated on the college's website, including the Red Folder;

Whereas: Facilities is in charge of maintaining and supporting all of the functional aspects of the campus, from academic buildings to the restrooms, as well as being one of the departments in charge of implementing various types of signage around campus;

Whereas: Having resources in restrooms allows for an easily accessible location to find materials provided by the college for a multitude of issues;

Therefore be it Resolved: The Student Government Association will cooperate with the department of Facilities to implement a QR code in restrooms across the campus of Ramapo College of New Jersey, frequented by students;

Therefore be it Resolved: The Student Government Association will work with departments on campus such as Facilities, Office of Title IX, Health and Counseling Services, and the Office of Violence Prevention to include their online resources into the QR Code;

Therefore be it Resolved: The Student Government Association will update the QR Code on an as needed basis to include future resources associated with other services or departments upon the request and discretion of that particular department or service.
